Sealed competitive quotations are invited from reputed agencies for the installation of 5 nos Temporary Hoarding Display (10' x 12') at Pathanamthitta-Pamba route during Sabarimala Season. The requirements are as follows.

The bidders should quote the rates in the schedule of quantities. The Envelope containing the quotations should bear the superscription addressed as per the form of Quotation Notice and should reach the Head Quarters by Hand/Post/Courier.

The full address of the firm should be given on the sealed envelope. Last date and time for receipt of Quotations is 09-11-2022 at 01.00 PM. Late Quotations will not be accepted. The Quotations will be opened at 4 PM on 09-11-2022 in the presence of the tenderers or their authorized representatives who are present at the time of opening.

Sealed quotations are invited for the works specified in the list above. The rates quoted should be including cost of material, fabrication charges, cloth printing charges, site rental charges, transportation charges, erection charges, levies etc. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above. Quotations not stipulating period of firmness and with price variation clause are liable to be rejected. The acceptance of the quotations will be subject to the following conditions.

1. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. On such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
2. No representation for enhancement of price once accepted will be considered during the currency of the contract.
3. Any attempt on the part of tenderers or their agents to influence the officers concerned in their favour by personal canvassing will disqualify the tenderers.
4. If any license or permit is required tenderers must specify in their quotation and also state the authority to whom application to be made.
5. The prices quoted should be inclusive of all taxes, duties, cesses etc which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery the course of execution of the contract.
6. Any sum of money due and payable to the successful tenderer or contractor from Government shall be adjusted against any sum of money due to Government from him under any other contracts.
7. Payment will be made only after completing the works upon the satisfactory performance of the work awarding authority.
8. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchases.
